DANGER AREAS IN BELIZE

The following is a summary of danger areas in Belize. These areas are used by the Belize Defence Force and British Forces Belize and are activated via Notices to Airmen (NOTAMs). The general aviation public is hereby informed of the latitude and longitude of these areas and the need to avoid these areas once they are activated.
