REVISED SCHEME OF CHARGES

The general aviation public is hereby notified that by means of Statutory Instrument No. 5 of 2010, the Government of Belize has enacted the CIVIL AVIATION (SCHEME OF CHARGES) REGULATIONS, 2009, **replacing** the Scheme of Charges detailed in the Colonial Air Navigation Order of 1968.

The CIVIL AVIATION (SCHEME OF CHARGES) REGULATIONS, 2009, **details the new fees** with reference to all aspects of Civil Aviation and will take force on 1st April, 2010.

TITLE	NEW FEE
1. <u>Certificate of Registration.</u>	
The fee payable on application for registration of an aircraft and issue of the relevant certificate, based on the maximum total weight authorized (MTWA) of the aircraft shall be in accordance with the following:	
a) Not exceeding 6,000 lbs.	\$100.00
b) Exceeding 6,000 lbs. and up to 12,500 lbs.	\$150.00
c) Exceeding 12,500 lbs. and up to 30,000 lbs.	\$325.00
d) Exceeding 30,000 lbs. and up to 100,000 lbs.	\$350.00
e) Exceeding 100,000 lbs.	\$450.00
2. <u>Certificate of Airworthiness</u>	
Upon making application for the issue or renewal of a Certificate of Airworthiness, the applicant shall pay in respect of a complete year of validity as follows:	
a) Not exceeding 6,000 lbs.	\$600.00
b) Exceeding 6,000 lbs. and up to 12,500 lbs.	\$840.00
c) Exceeding 12,500 lbs. and up to 30,000 lbs.	\$1080.00
d) Exceeding 30,000 lbs. and up to 100,00 lbs.	\$1200.00
e) Exceeding 100,000 lbs.	\$1500.00

<p>11. <u>Technical Assessment of Foreign Registered Aircraft</u></p> <p>Upon making application for the technical assessment of a foreign registered aircraft operated under the terms of a Belize Air Operators Certificate, Operating Certificate or Operations Authorization, the applicant shall pay in respect of each complete year of validity applied for in respect of the certificate, the cost of any investigation required by the Department of Civil Aviation, plus:</p> <p>a) Not exceeding 6,000 lbs. \$625.00 b) Exceeding 6,000 lbs. and up to 12,000 lbs. \$875.00 c) Exceeding 12,000 lbs. and up to 30,000 lbs. \$1125.00 d) Exceeding 30,000 lbs. and up to 100,000 lbs. \$1250.00 e) Exceeding 100,000 lbs. \$1500.00</p> <p>12. <u>Statement of Airworthiness for Export, Certificate of Airworthiness for Export, Special Flight Permits or Special Airworthiness Certificates</u></p> <p>When an application is made for a statement of airworthiness for export or Certificate of Airworthiness for Export in respect of an aircraft the applicant shall pay the full cost for investigations required by the Department of Civil Aviation plus a charge of:</p> <p>a) Not exceeding 6,000 lbs. \$120.00 b) Exceeding 6,000 lbs. and up to 12,000 lbs. \$240.00 c) Exceeding 12,000 lbs. and up to 30,000 lbs. \$600.00 d) Exceeding 30,000 lbs. and up to 100,000 lbs. \$1200.00 e) Exceeding 100,000 lbs. \$2000.00</p>

<p>13. <u>Authorization of Examiners</u></p> <p>The fee to be paid upon making an application for appointment as an authorized examiner to conduct tests for flight crew ratings.</p>	\$150.00
<p>14. <u>Approval of Training Courses</u></p> <p>The fee to be paid upon making an application for the approval or renewal of approval of a flight training school to conduct courses of training for the:</p> <p>a) Commercial Pilot's Licence (Aeroplanes) b) Commercial Pilot's Licence (Helicopters) c) Private Pilot's Licence (Aeroplanes/Helicopters)</p>	\$1000.00 \$1000.00 \$1000.00
<p>15. <u>Fuel Facilities</u></p> <p>When an application is made by a person for the approval of an organization for the purpose of distribution or storage of aviation fuel, the fee shall be as follows:</p> <p>a) For the investigation required by the Department of Civil Aviation b) For the issue/renewal of an annual approval.</p>	\$200.00 \$100.00
<p>16. <u>Additional charges where functions are performed off station.</u></p> <p>When an application is made for the Department of Civil Aviation to perform a function in respect of which a charge is specified in these regulations as a result of which the Department deems it necessary for a member, employee or representative to travel outside the place which he/she is normally stationed, the applicant shall pay, in addition to the appropriate charge specified, a charge equal to the additional cost thereby incurred during which such member, employee or representative is absent from the place in which he/she is normally stationed.</p> <p>17. <u>Overtime fee for Air Traffic Services</u></p> <p>For the provision of air traffic services per hour or part thereof outside the normal operating hours of the Philip S. W. Goldson International Airport.</p>	\$250.00
